NOTIFICATION OF INTENT TO INVITE BIDS

- 1. Ministry of National Defence of Romania intends to invite eligible companies to participate at "National Competitive Bidding +" ("NCB+") for the implementation of works of the project 2018/3AF35028-00 PROVIDE AIRCRAFT PARKING PLATFORM. The project is included in the Capability Package CP 9A1385 Defensive and Offensive Air Assets in SACEUR'S AOR and is commonly funded from NATO Security Investment Program.
- 2. Summary Description of Project: Technical Design and Execution of Works for the Project 2018/3AF35028-00 PROVIDE AIRCRAFT PARKING PLATFORM:

The project includes the following main works:

- Platform Alpha (rehabilitation) and Taxiway ECHO 1 (new designed total area: 6,565 sqm)
- Provide parking platform total area: 25,210 sqm divided as follows:
 - o Load bearing area: 20,930 sqm
 - o Shoulder area: 4,280 sqm
- Drainage system
- Electrical system
- Airfield Lighting System

The project 2018/3AF35028-00 - PROVIDE AIRCRAFT PARKING PLATFORM is required to provide facilities in support of the NATO deployment of one tactical fighter squadron (16 aircraft, in addition to the 4 which are in place for national purposes) and is programmed in the approved CP 9A1385.

The scope of the project is to provide a new rigid platform, with a total area of 25,210 m2 (composed by 20,930 m2 load-bearing area, 161 m long and 130 m wide, plus 4,280 m2 shoulders 7.5 m wide). The apron structural package is designed with 34 cm BCR 5 cement concrete, 25 cm stabilized ballast with hydraulic binders and 40 cm ballast foundation with a 50 cm stabilized earth form layer with hydraulic binders and non-woven geotextile. The platform will be surrounded by an earth berm on three sides, in order to protect exposed sites from potential blasts. Drainage, electrical and floodlight systems complete the scope.

A new taxiway "Echo 1" will be built as an extension of Echo taxiway to provide access to the newly designed platform. This taxiway, 177m long, 22,5 m wide, with 7,5 m shoulders, will be built north of the Alpha platform.

17. Bidding is conducted according to Law no. 98/2016 on Public Procurement and is open to all bidders from NATO member countries ("29E"). Only eligible companies from NATO member countries ("29E") are allowed to participate in the bidding "NCB+".

Complete set of bidding documents in Romanian language, including qualification requirements, bidding data sheet, "Cahier des Charges", technical specifications, drawings, bill of quantities, security guarantee and contract forms, are available on the Romanian Government Official site for Bidding https://www.e-licitatie.ro/pub with identification no. All bids shall be accompanied by a Bid Security of 98.015,55 euro, representing 1% of the total rough cost estimate.

The contracting authority shall demand performance guarantee representing 10% of the overall value of the contract.

To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria as specified in the bidding documents. For the qualified companies, the criterion for awarding the contract is the best quality/price criteria. (40% price, 20% technical experts, 40% technical criteria)
